



## **The.buzz Q1 2018 30/30 Rebate Program**

The.buzz domain name registry is pleased to announce a new promotional program for our registrar partners. We are offering a rebate program, from January 1, 2018 – March 31, 2018.

### **1. New Registration Rebate:**

During the program period, the .buzz registry will offer a \$15 rebate on all domain names registered (on the first year registration wholesale fee) when a registrar exceeds the minimum registration threshold of 30 .buzz domain names per month.

### **2. Renewal Rebate:**

During the program period, the .buzz registry will offer a \$10 rebate on all domain names renewed (on the first year of the renewal wholesale fee) when a registrar exceeds the minimum renewal threshold of an average of 30 .buzz domain names per month over the length of the rebate program.

### **3. Program Monthly Periods:**

The program period (January 1, 2018 through March 31, 2018) is broken down into whole months during which the registration and renewal performance will be measured against the program monthly thresholds:

- January 1-31, 2018
- February 1-28, 2018
- March 1-31, 2018

You may elect to withdraw your eligibility for a renewal rebate during any of the above monthly periods, without cancelling your participation in this rebate program. Simply notify The.buzz domain registry in advance of the monthly period you wish to withdraw from the renewal rebate.

## The.buzz Q1 2018 30/30 Rebate Program Terms & Conditions

In order to participate in our **The.buzz Rebate Program**, the Registrar accepts the following terms and conditions:

1. **New Registration Rebates** are applied to new creates net of grace period deletes, and paid out approximately 45 days after the end of each month. Rebate will apply per .buzz domain name, on the first year's registration fee, when registrar exceeds the specified monthly threshold registration volume during the program monthly periods.
2. **Renewal Rebates** are applied to renewals net of grace period deletes, and paid out approximately 45 days after the end of each month. Rebate will apply per .buzz domain name, on the first year's renewal fee, when registrar exceeds the specified monthly threshold renewal volume during the program monthly periods. Registrar may elect to withdraw their eligibility for a renewal rebate for any of the program's (whole) monthly periods, without cancelling their participation in this rebate program.
3. The promotional **Program Monthly Periods** will run from January 1, 2018 through March 31, 2018 (UTC Time), and the registration and renewal volume will be measured on threshold targets for each whole month.
4. Registrar will provide the .buzz Registry with physical mailing address for payment remittance for issuing rebates, by sending the information to email address [bill@the.buzz](mailto:bill@the.buzz)
5. The .buzz Registry may terminate this promotional program at any time, and will notify the registrar of the program termination.
6. Registrars may only participate in one .buzz Registry sales promotion during this program period, in the event that other promotions are offered concurrently.
